**COVID-19 UNDERSTANDING AND RELEASE OF LIABILITY**

The undersigned agrees to release the Show from liability and waive any and all claims for expenses and/or medical charges related to any diagnosed medical condition that arises from or is related to contact with the COVID-19 virus if contracted before, during, or after the 2020 Show (inclusive dates: December 20 and 21, 2020).
